1. **FULL TIME INTERIM**

**OTHER CONCERNS:**

- a. **Mileage** – 54.5¢ per mile, round trip as of January 1, 2018, which is the current IRS mileage rate. If more than 50 miles one way is traveled, consideration in remuneration should be allowed for travel time.
- b. **Remuneration** - have it on hand to reimburse one time persons immediately; or by arrangement with congregation/Pastor.
- c. **Weddings, Funerals, etc.** – Are worship services, please see above.
